- AWSC Tail Passes: You are required to have your AWSC membership number and your Wisconsin DNR snowmobile registration number when purchasing your \$10 trail pass.
  - You must be a current member of a club to get the discounted \$10 trail pass.
  - O Your AWSC number does not change from year to year.
  - Trail passes can be ordered online through the AWSC website or send in a check with a form that you can print off the AWSC website
  - o It can take up to 21 days for delivery through USPS (even longer during the holidays).
  - System checks against the DNR's data base so your name and address has to match

exactly with what the DNR has in their system (example - "Bobby" and "Robert" don't match).

- Please note that AWSC does not list "significant others" on the AWSC roster, you will have to do individual memberships
- If you are married and kept your maiden name please let Jen know and she will make a note of it with the AWSC office
